- Executive Board meetings are held monthly on the first Tuesday, per the Bylaws Standing Rules. Unless otherwise noted, meetings are held at Cutten Elementary School in the staff room. During this period of social distancing/distance learning, Executive Board meetings will be held through online channels.
- There are three Association meetings per year. The Calendar is approved at the first Association meeting. A Treasurer's Report that includes activity from the last Association meeting to the current is required at each meeting. Each Association meeting has additional requirements.
- To change date/time/location of a regularly scheduled Executive Board meeting requires the President to inform the Association 10 days in advance. An example of this is the December meeting, which has been held offsite as a potluck.
- Annual elections are held in April. This has been revised in our Bylaws. The nominating committee is elected at the Association meeting during Founder's Day.
